

SERVICE AGREEMENT

Welcome!

We are very excited to bring you on as a new client! To make sure we are on the same page regarding our services, policies, and expectations, please thoroughly read this Service Agreement (the "**Agreement**"). If you have any questions at all, please reach out to ask us before agreeing.

1. **Parties.** This Agreement is made between Sages Amore Organics, LLC, a Limited Liability Company operating in the State of Oregon ("**Sages Amoré Organics**," "**we**," "**us**," and "**our**") and you ("**you**" and "**your**"), the person who has signed or clicked "I Agree" (or something similar) to this Agreement.
2. **Our Commitment to You.** It is our goal to help you achieve all of your personal wellness goals. With this in mind, we will strive to provide you with the highest quality Yoga, Health Coaching, and Energy Work Services, which are outlined in Schedule "A" (the "**Services**"). In order to provide you with the best possible experience, we will also do the following:
 - 2.1. Our one-on-one programs will be customized to your unique individual needs, goals and abilities, while group programs will take into consideration the current level and general fitness profiles of registered participants.
 - 2.2. We will do our best to clearly communicate with you about the Services, such as preparation instructions, scheduling details, and follow-up information.
 - 2.3. You can expect to learn how to Live a Balanced and Healthier Life through Yogic, Ayurvedic and Energetic Methods.
3. **Qualifications.** We hold the following professional qualifications and certifications: Certified Health Coach, Registered Yoga Teacher, Shaman and Reiki practitioner.
4. **Scope of Practice.**
 - 4.1. Here is what we will be doing together: I provide various types of Yoga Instruction and workshops, health coaching, and energy balancing. My work will equip you with sufficient information and practical applications for further development of your knowledge, allowing you to decide what, how and when to implement them into your daily life.
 - 4.2. Here is what we will not be doing together: I am not a Doctor. I do not provide medical care, prescribe medicines, or diagnose, treat or heal physical or mental medical conditions.
5. **Scope of Practice/Not Professional Medical Advice.** Please know that we only have the qualifications listed above in section 3 and that the scope of our practice in offering our services is to work with you to raise awareness and work towards best practices for your general health and wellness. We do not offer professional medical advice, and we highly recommend you seek medical professional advice if you feel you have a disease that must be diagnosed or treated.
6. **Our Expectations.** Here is what we expect of you:
 - 6.1. **Respect.** We expect you to show kindness and respect to all staff, other participants, and everyone you interact with at Sages Amoré Organics. Check your negativity at the door, leaving it outside of Sages Amoré Organics or in a different room if on Video or Phone calls.
 - 6.2. **Time Integrity.** We expect you to show up on time to each scheduled session, ready to participate. We also expect you to honor the cancellation policy detailed in section 6 below.
 - 6.3. **Communication.** We expect you to be upfront and honest about any health issues you have and your relevant medical history. Assume nothing - always communicate. Also, please let us know if there is anything we can do to improve the Services. We always appreciate constructive feedback from our clients!
 - 6.4. **Perfume.** We expect you to show up with no perfumes or similar chemicals having been used, only essential oils are permitted.
 - 6.5. **Unwell?** We expect you to reschedule or switch to a Video Call if you are sick. Please do not attend any sessions if you are unwell.

- 6.6. Limits.** We expect you to always give 100% and still have fun. Listen to your body, and do not push yourself beyond what is comfortable. Know your body's limits and always stay within these limits.
- 6.7. Payment.** We expect you to always pay on time. If payment is ever an issue, talk to me before being late with a payment.
- 6.8. Technology.** We expect you to Turn Off your Bluetooth and WiFi, switch to Airplane mode, and Silence or Turn Off all applicable electronic devices.
- 7. Sensitivity and Scheduling.** Due to some of my previous experiences, sometimes I may suddenly become unwell or need to rest. It is vital that I protect my health as I have autoimmune, multiple chemical sensitivities and energetic sensitivities to wifi cellular and Bluetooth that cause physical symptoms due to jet fuel exposure while serving in the Marines in 2009. I had a military trauma and still suffer from PTSD. Between my mental and physical health issues, I must have open communication about triggers mentally, emotionally, energetically and chemically, as I may need to reschedule or switch to video or phone options when needed. My symptoms come in waves, and the jet fuel affects my entire body, from my brain (migraines and inflammation), eyes (pressure, pain and distortions), gastrointestinal (pain and inflammation) to the liver, kidney pain, nerve pain, and even pain in the center of my bones.
- 8. Term and Termination.** This Agreement begins when you sign or agree to it, and it will continue for the duration of the Services as agreed upon between you and Sages Amoré Organics (the “**Term**”).
- 8.1.** The Agreement may be terminated by either party at any time by providing three (3) days advance written notice to the other party via email. However, if you terminate the Agreement before the Term is complete, you must make all payments as outlined in Schedule “A” Services.
- 9. Payment.** Payment details and cost for the Services are outlined in Schedule “A” Services.
- 9.1. Payment Method on File.** Feel free to keep a credit card or other payment method on file with us. By doing so, you give us permission to charge the payment method for Services rendered or other fees (as applicable).
- 9.2. Declined Charge.** If credit card/debit card is declined, we will need to pause any ongoing Services until you update your payment information and pay the amount due.
- 10. Fluctuation of Payments.** You understand that we reserve the right to change our prices and that in your acceptance of these new prices and continued payment, you continue to be bound to all the terms of this Agreement. We will always provide at least 30 days notice before raising any prices, and we will communicate with you to ensure you are aware of any changes.
- 11. Cancellations and Refunds.** You agree to our refund and cancellation policy, as listed below:
- 11.1. Refunds.** All sales are final.
- 11.2. Cancellation & Reschedule Policy.** If you have to cancel or reschedule a session for any reason, please give 24 hours' notice. If you give less than 24 hours' notice, we may not be able to reschedule your session, and no refund will be provided. If you are unwell and give less than 24 hours' notice, we will do our best to reschedule, provided communication is available, and it is not a repeat issue.
- 12. No Guarantees.** Although we will do our very best to help you achieve your goals, the success of the Services ultimately depends on you. For this reason, Sages Amoré Organics cannot guarantee the success of, or any particular outcome from the Services.
- 13. Ownership of Materials.** All the content that we have provided to you, including but not limited to videos, documents and PDFs, are for your use only and are not to be re-distributed or re-used. Sages Amoré Organics retains all intellectual property rights associated with its content.
- 14. Substitute Services.** Sages Amoré Organics has the right to substitute services. This means that if we ever need to switch to online services or asynchronous virtual offerings due to circumstances beyond our control, we have the right to such a substitution for in-person classes, as necessary.
